

BASIC TRAINING IN MEDIATION

Mediation skills and strategies for mediation.

- This is a 50 hour (6 days) professional training course for mediators, attorneys, advocates, social workers, psychologists, and allied professionals who provide dispute resolution services.
- The course includes the legal, cultural, psychological and financial implications background for mediation skills, and conflict resolution.
- By the end of the course delegates will be able to follow a structured mediation process to conduct a mediation service for the drafting of a professional Parenting Plan and/or Memorandum of Understanding.
- 25 CPD points will be obtained.
